CHAMPIONSHIP QUALIFIER INFORMATION:

A stroke play competition based on the lowest gross scores:

Age Division	Holes Played
Ages 13 - 15	36 holes (over 2 days)
Ages 16 - 18	36 holes (over 2 days)

*Any junior who wishes to qualify for the Junior PGA Championship must play 36 holes from the same tees as the 16-18 year old age division and pay the same entry fee.

OFFICIAL ENTRY APPLICATION:

- Participants must qualify in the PGA Section in which they reside.
- Entry must be filed on an official entry application, or on-line for those sections which have on-line entry available.
- Please photocopy the application and give to your friends to apply, play and have fun.
- Completed entry applications with the applicable entry fee, must be received by the PGA Section contact as noted on this application prior to the entry deadline.
- Please make your check payable to and mail it to your local PGA Section office.

CHAMPIONSHIP INFORMATION:

- 156 boys and girls who are 18 and under through the final round of the Junior PGA Championship on August 3, 2012 and who have not started college.
- Players are not allowed to have caddies at any stage of the Championship, except in practice rounds.
- Application for entry is subject to acceptance by the PGA Section and the PGA of America, the administrator of the Championship.
- Applicant agrees that, in the event of acceptance, he/she may be rejected at any time and stage of the championship.
- PGA reserves the right to limit entry, adjust dates, format and other details to fit conditions prevailing at the time of the event.

In consideration of the applicant's participation in The PGA Section Championships, Qualifiers and The Junior PGA Championship: 1) the applicant and the parent/guardian hereby release The PGA of America, The PGA Section, PGA Tournament Corporation, Inc., Sycamore Hills Golf Club, host sites of PGA Section events, sponsors and all of each company's respective officers, directors, employees, agents, subsidiaries and affiliates from any and all liability associated either with acts or omissions of such parties, or with accidents or injuries sustained by the applicant or parent/guardian in connection with the tournaments; 2) the applicant grants and assigns his/her individual media/photo rights respecting participation in the competition, without exception to the sponsors, PGA of America, PGA Tournament Corporation, Inc., and the PGA Section. Applicant information will be used for internal purposes only in conjunction with PGA of America activities and programs. Additionally, The PGA of America will provide event sponsors of the PGA Junior Series and Junior PGA Championship with the names and mailing addresses of its participants.

It is a condition of participating in this event that the competitor is not permitted to use a motorized golf car during the event competition. Notwithstanding the foregoing, The PGA of America is committed to conducting golf competitions within the parameters of the Americans With Disabilities Act. Players who request relief under the Americans With Disabilities Act and seek a reasonable accommodation for their disability by the use of a motorized golf car during the event competition shall be required to submit their request in writing to the Special Board on or before the entry deadline date for review and determination. The Special Board will schedule a hearing to allow the applicant the ability to present evidence to support the applicant's position.
